APPLICATION FOR PLANNING PERMISSION WITHOUT COMPLIANCE OF CONDITION(S) - DC/19/01268 Proposal: Application under section 73 of the Town and Country Planning Act DC/18/05221 without compliance with conditions 3 (Approval of reserved matters) and 7 (Provision of parking).

The members agreed that the requested change on the application from a development as a whole to custom build unit (not specified on the original application) leaves the village open to a prolonged possibly open-ended development. On the basis of wanting the project to be completed in a timely and coherent manner the members object to the application.

The members also note BMSDC were keen to ensure this coherent approach on previous applications in the village namely 0595/17 and DC/17/03371 for the erection of 3 dwellings at Lugano, The Street, Stonham Aspal

19.47 Finance

19.47.1 Authorisation of Payments

Members approved the following payments and signed the authorisation and cheque book Peter Emberson for the purchase of signs, stencils and temporary paint for awareness of dog fouling in the village. £46.58

19.47.2 Bank Mandate

- Speed signs which cost between £2.5-3k Cllr Emberson to find out more and liaise with District Cllr re funding
- Village Hall car park Cllr Emberson to speak to the Village Hall committee regarding funding required
- Phase two of the recreation ground project which was going to include an all-weather surface

It was agreed to seek ideas from the wider community via the village website and village Facebook page. Inviting residents to bring their ideas to the Annual Parish Meeting
