Highways have approved the site for the sign, however the Parish Council must use an approved contractor who has checked for utilities on the site. Clerk to find out who approved contractors are and obtain a quote.

20.31 Tree Warden Update

Cllr Rae Betts updated the members on the tree warden

- The Clerk has confirmed that Edwin is covered under public liability as long as he has required training
- The Warden, Edwin, will contact landowners, see who is happy to plant trees and hedgerows
- Edwin would like to get volunteers who would be interested in any of the following: getting training on tree surveying getting trained on tree planting would like to help with tree planting
- Cllr Betts will add a question into the village survey asking if anyone would like to get involved
- Edwin to write a short piece about his role in the village magazine
- Edwin to get his contact details added to the back of the village magazine

Other ideas

Volunteers can then take park in updating Suffolk hedgerow survey and Ancient Tree Survey online.

In lockdown - we could encourage people to take part in Edwin's suggested training during lockdown but of course stay 3m away from each other!

Any activities will use Woodland Trust risk assessment. A copy of which will be sent to the Clerk.

Edwin Has a DBS certificate, safeguard training and first aid training.

20.32 Village Survey

Members agreed the format of the survey however reference to individual planning applications would be changed to how many there has been in the past. The aim is to distribute electronically and in hard copy by end of April.

20.33 Highways

- **20.33.1** SIDS/TVAS is progressing a post has been put up outside The Old Rectory and existing post identified by The Rectory.
- 20.33.2 Edge of carriageway lining Highways confirmed this has not happened as payment has only just been received. The Clerk confirmed it cleared the Parish Council's accounts on 5th February 2020.
- 20.33.3 Speeding on Angel Hill the members discussed the issue of speeding on Angel Hill and the site of two recent fatal accidents. However as the sites fall outside of the Parish so members agreed they could not really assist.
- 20.33.4 Update on other current issues- Flooding on Scotts Hill is still an issue and drainage needs clearing. Clerk to follow up with Highways.

20.34 Finance

20.34.1 Authorisation of payments
