Eric was known in local football circles as Mr Stonham Aspal for his dedication and hard work to maintain and develop Stonham Aspal football club for over 50 years. He was also the driving force behind the future development of the football ground to bring additional sports facilities to the benefit of the village and surrounding areas.

20.43.1 DC/20/01328 | Householder Application - Erection of detached garage/workshop (following demolition of existing garage) | 1 Town House East End Road Stonham Aspal Stowmarket Suffolk IP14 6AR

The members unanimously agreed they had no comment to make on this application

**20.43.2** DC/20/01340 | Householder Planning Application - Erection of a two storey front extension and workshop | Broad Green Cottage Pettaugh Road Stonham Aspal Stowmarket Suffolk IP14 6AT

The members unanimously agreed they had no comment to make on this application

20.43.3 Re - Consultation DC/20/00682 | Application under S73 for removal or variation of a condition following grant of planning permission 4847/16 dated 29/3/2017 and subsequent S73 DC/18/05221 dated 19/02/2019 without compliance of Condition 2 ( approved plans and documents) - To remove reference to "no dig" construction via Arboricultural Assessment by AT COOMBES ASSOCIATES, and alterations to layout and access. | Green Farm Crowfield Road Stonham Aspal Suffolk

The members unanimously agreed they had no comment to make on this application

20.43.4 Re-consultation DC/20/00495 | Application for approval of reserved matters (appearance, landscaping and scale) following outline approval given under DC/20/00682 (Outline planning permission sought for the erection of 9 No. dwelling houses with associated access and layout).
| Green Farm Crowfield Road Stonham Aspal Suffolk

The members unanimously agreed they had no comment to make on this application

20.43.5 DC/20/01375 | Application under S73(a) for variation of Condition 18 relating to DC/19/05249 - To enable the 21 holiday lodges/caravans (labelled R1-21 on the approved plan) to be occupied all year round but no person or persons to occupy the lodges/caravans R1-21 for a period exceeding 28 days in any calendar year. | Stonham Barns Pettaugh Road Stonham Aspal Stowmarket Suffolk IP14 6AT

Members unanimously agreed to object to this application on the basis that it appears to be a re hash of application DC/18/04982 which was refused and that the reasons for refusal still apply. The change would undermine the sites definition as a holiday park, the closed month is integral to this as agreed in the master plan

The application online also appears to be sketchy, missing key documents ( there is reference to a letter which is not included online) and inadequate for proper consultation.

"The proposal to remove the break period as a variation to Condition 19 of application 3150/15 without adequate justification, evidence or robust explanation to warrant approval. The proposal is in direct conflict with a fundamental aspect of the assessment made under 3150/15. Officers are not satisfied that the removal of the break period would retain adequate control of the caravans to retain active tourism use generation that secures economic and tourism benefit that otherwise outweighs harm of unsustainable development of long term residential use provision where there is insufficient infrastructure to support and would otherwise lead to poor social cohesion. The scheme would, if approved, by reason of the removal of the break period generate environmental and social harm representing an inappropriate intervention upon Policies GP1, HB1, H11, H16, CL8, E8, E9, E12, T9 and T10 of the Mid Suffolk Local Plan (1998), Policies FC1, FC1.1, CS1, CS2, CS5, CS6 and CS11 of the Mid Suffolk Core Strategy Focused Review (2012), and the values of the NPPF 2018. Consequently, the proposal is therefore unacceptable and is at variance to the development plan and national planning policy."

**20.43.6** DC/20/01438 | Full Planning Application - Change Use of land for the stationing of 5 holiday lodges. | Stonham Barns Pettaugh Road Stonham Aspal Stowmarket Suffolk IP14 6AT

Members unanimously agreed to object to this application on the grounds that it falls outside of the area previously agreed under the Master Plan for Stonham Barns. It contravenes national planning policy frame work in that it is not proportionate and sustainable (MSDC Chief planning officer has acknowledged that the development is unsustainable).

There is also a need for developments need to be carbon neutral and as all units are heated with and cook with gas this would not be the case.

The council members have concerns over the water supply which is possibly via un licenced boreholes. In addition, there are question marks over the robustness of the electricity and foul water infrastructure within the site, as evidenced during 2019 with onsite power outages and overflow of foul water into surrounding ditches and water courses

It also represents the loss of agricultural land.
