The members unanimously agreed to object to this application on the basis that it is part of a piece meal approach to develop the site instead of a complete plan which the council believes MSDC requested in January 2021.

The PC think the original site for the security guards caravan was a better option and more in keeping with the overall plan. The new site positions the caravan in an area where there are currently none.

The Parish Council would also like reassurance that this is a replacement for the existing security guard accommodation and not additional.

The Parish Council also believe that the caravan should remain the property of Stonham Barns. Who can ensure it is only used for a full time (not part-time) security guard role and its purpose is not confused with holiday or residential lodges.
