21.92 Apologies and Approval of Absences

Consideration of Planning Applications

21.97.1 DC/21/04686 | Full Planning Application - Change of use of agricultural land to domestic garden curtilage | Ash Lodge The Street Stonham Aspal Suffolk

The members of Stonham Aspal Parish Council unanimously agreed that they are neutral to this application, however would request that there are restrictions preventing the building of permanent structures on the plot. Particularly as the site is outside of the settlement boundary.

There were no other planning matters

21.98 Quiet Lanes consultation

The Parish Council received two response to the Quiet Lanes consultation. They questioned the impact the scheme would actually have and the validity of the lane to Broughton Hall as a quiet lane, one reply siting the cars of school parents who park off the Lane each day at drop off and pick up times.

Additionally, it was questioned whether the actual speed limit and damaged 30mph signs should take higher priority.

The members of the Parish Council and members of the public present unanimously agreed to the quiet lanes designation for both sites subject to confirmation of the impact of school parents.

The Parish Council have previously been advised by SCC Highways that the replacement of road signs is on hold because of lack of money. However, this seems contrary to the investment in SID and efforts to improve road safety. The members agreed to invite Cllr Hicks to respond on the subject of replacing road signs.

21.99 Finance

Update on highways issues

The meeting had a brief look at statistics from the SID which need to be made available in an agreed format online. The sign will be moved to Scotts Hill shortly (the move had been delayed because of the expected closure of Scotts Hill. It was also suggested that the sign be trialled at each end of the village on the A1120 in similar positions at the entrance to the village as other local villages such as Stonham Parva and Forward Green use for their signs.

It was also questioned why the sign was not solar powered, it was thought it was because these signs are not moveable but will confirm
