22.39.1 DC/20/01547 | Full Planning Application - Change of use from livery and agricultural land to use as touring caravan and camping site and for storage of caravans, siting of caravan for use as reception/site office, erection of 4 No. toilet/shower blocks and use of livery building as store room. | Stonham Barns Pettaugh Road Stonham Aspal Stowmarket Suffolk IP14 6AT

Members unanimously objected to the application on the same basis of previous comments. Including environmental health concerns, they specifically highlighted the ability of the site to cope with the additional toilet and shower blocks as the water supply to the area is poor. They also questioned the ability of one Elsan point to cope with the waste from a potentially large number of caravans

It is over and above the original master plan

Members assumed that the 'future club house' is not part of this application and will be subject to a separate application in due course.

They would also ask that it be clearly stipulated that the site office is not a residential unit or used as such by anyone.
