1. Apologies and Approval of Absences

Apologies were received from Cllr Jean Timms and her absence was approved. Apologies were also received from Cllr Charles Tydeman. Cllr Rob Stevenson did not attend the meeting.

2. Declarations of Pecuniary or Non-Pecuniary Interests by Members There were no interests declared by any of the Members.

3. Approval of Minutes of the Previous Meeting on 17 July 2018

Minutes of the previous meeting of the Parish Council on 17 July 2018 were received and approved as a true record and signed by the Chair.

Mention was made of a Speed Watch scheme as a possible traffic calming measure, vegetation at the side of The Street, the lack of safety for the use of buggies outside the school and insufficient space for a footpath to exist in the immediate area.

The anticipated high level of traffic will also affect residential amenity issues. The village's school is already at full capacity and will not be able to cope with the pressure of families moving into the new homes on either this or any other new developments. The land used for agricultural use behind the proposed development would become isolated as access to it would become affected. There is also insufficient infrastructure to support the development of new homes.
